**Request for Proposals (RFP) 2013-02**  
**Technical Assistance, Training and Counseling Evaluation for**  
**National Mortgage Settlement Fund Agreement**

At the April 26, 2013, Board Meeting, Florida Housing's Board of Directors authorized that Florida Housing enter into contract negotiations with Florida Housing Counseling Network to provide technical assistance, training and counseling evaluation through the National Mortgage Fund Agreement. If contract negotiations fail, then Florida Housing is authorized to enter into contract negotiations with the Florida Housing Coalition, Inc.

Stat., et. al. or failure to post the bond or other security required by law within the time allowed for filing a bond shall constitute a waiver of proceedings under Chapter 120, Fla. Stat.
