

<p>General update regarding compliance monitoring</p>	<p>Florida Housing remains committed to finding ways to be creative and flexible in its processes and limiting the amount of disruption to the flow of business while simultaneously finding and maintaining a safe and healthy environment for all those who live or work at a FHFC-financed development while mitigating risk to both people and programs.</p> <p>Florida Housing will continue to closely monitor and evaluate information and guidance provided by state and federal agencies and provide notice when new directives are issued. <p>Management Review and Physical Inspection (MRPI)</p>	<p>Management reviews and physical inspections are temporally postponed beginning 4/1/2020 and ending 9/30/2021 and will resume 10/1/2021</p> <p>Per HUD-waiver requirements, postponed management review and physical inspections of HOME program participants will be conducted within 120 days from the end of the period.</p> <p style="text-align: right;">(Updated 1/28/2021)</p>
<p>Owner's response to MRPI and program report discrepancies</p>	<p>Response schedule remains unchanged. Contact the compliance monitoring agent who is responsible for the particular MRPI or program report if unable to respond as directed.</p> <p style="text-align: right;"><i>(3/20/2020)</i></p>
<p>Owner's response to written notification of noncompliance</p>	<p>Response schedule remains unchanged. Contact the compliance monitoring agent who is responsible for the particular MRPI or program report if unable to respond as directed. <p>Resident Programs, *Common Areas* and Amenities</p>	<p>Monitoring has been temporarily halted for Florida Housing-required resident programs or amenities that are social or recreational in nature and encourage gathering.</p> <p>*In accordance with IRS Notice 2021-12: FHFC will allow the temporary unavailability or closing of common areas and amenities at HC, TCAP and TCEP properties through September 30, 2021, if the unavailability or closing is in response to the COVID-19 pandemic.*</p> <p style="text-align: right;">(Updated 1/28/2021)</p>

<p>Resident file *documents and signatures*</p>	<p>The HUD 4350.3 Occupancy Handbook contains guidance regarding extenuating circumstances that cause delay in the execution of its consent forms and HUD 50059 tenant certification and until the IRS issues guidance to the contrary, Florida Housing will emulate HUD and apply the extenuating circumstances principals and postpone execution of all verification and certification documents. The owner must document the reasons for the delay in the resident file (“Applicant/resident did not sign due to COVID-19 risk.”) and indicate how and when the tenant will provide the proper signature.</p> <p>The review of documents provided by an applicant/resident is acceptable third-party verification according to the HUD 4350.3 guidance. However, again per the 4350.3, it’s acceptable to resort to the Family Certification method (self-certification) if the information cannot be verified by another acceptable verification method. In these instances, the owner must include in the resident file a description of the attempts first made to obtain the actual third-party verification documents. Paragraph 5-18 E in the 4350.3 includes guidance for documentation requirements when third-party verification isn’t available. Currently, the existence of extenuating circumstances that might delay actual execution of a document is not reason enough to skip directly to Family Certification. Please note that HUD requires a Family Certification to be notarized and include a statement to the veracity of the information provided; HUD allows an owner to witness the family signature(s) in lieu of notarization.</p> <p>When there is a delay in obtaining and/or witnessing the actual family signature(s) due to extenuating circumstances this fact should be noted initially and then when the signatures are subsequently obtained a reference to the original statement can be made to explain what would otherwise appear to be tardy execution of the “Family Certification” (similar to a “true and correct as of [date]” statement). The date the signature was obtained must be entered on the document.</p> <p>*When income determination is conducted by telephone, the written record of the telephone conversation should include the penalty of perjury statement that pertains both to the person taking the statement and the applicant.*</p> <p style="text-align: right;">(Updated 1/28/2021)</p>
<p>Tenant income certification requirement in IRS regulation 1.42-5(c)(1)(iii)</p>	<p>Owners of HC, TCAP, TCEP low-income buildings are not required to perform income recertifications under 26 CFR Section 1.42-5(c)(1)(iii) in the period beginning 4/1/2020 and ending 9/30/2021. The owner must resume the income recertifications as due not later than 10/1/2021. Student documentation is not affected and shall continue to be collected as due.</p> <p style="text-align: right;">(New 1/28/2021)</p>

First anniversary income determination requirement in Rule Chapter 67-53 F.A.C.	<p>Owners of participants in Florida Housing’s CWHIP, HC, MMRB, RRLP, SAIL, TCAP, and/or TCEP which certify 100% of the Development’s units as low-income are not required to perform first anniversary income determinations under Rule 67-53, Compliance Procedures, in the period beginning 4/1/2020 and ending 9/30/2021. The owner must resume the first anniversary income determinations as due not later than 10/1/2021.</p> <p style="text-align: right;"><i>(New 1/28/2021)</i></p>															
Utility Allowance	<p>Continue the usual electronic submission of the Energy Consumption Model (ECM) utility allowance materials to Florida Housing for its approval.</p> <p style="text-align: right;"><i>(3/20/2020)</i></p>															
Program Report Submission	<p>Electronic submission of program reports to Florida Housing continues to be due on or before the 15th day of the month following the end of the calendar month being reported. Electronic submission to the compliance monitoring agent, including the 10% sample of TICs executed during the period being evaluated, is unchanged.
