## AMENDED ORDER GRANTING WAIVER OF RULES 67-21.026(13)(e), 67-21.014(2)(r)6, and 67-48.0072(17)(f), FLA. ADMIN. CODE (07/11/2019) CORRECTING SCRIVENER'S ERROR

THIS CAUSE came for consideration and final action before the Board of Directors of the Florida Housing Finance Corporation (the "Board") on August 23, 2024. On July 24, 2024, Florida Housing Finance Corporation ("Florida Housing") received an Amended Petition for Waiver of Rules 67-21.026(13)(e), 67-21.014(2)(r)6, and 67-48.0072(17)(f), Fla. Admin. Code (07/11/2019) (the "Petition") from Ambar Trail, LTD (the "Petitioner") to allow Petitioner's General Contractor to perform construction or inspection work that is normally performed by subcontractors. Notice of the Petition was published July 25, 2024, in Volume 50, Number 145, of the Florida Administrative Register. Florida Housing received no comments regarding the Petition. After careful review of the record and being otherwise fully advised on the premises, the Board hereby finds:

1. The Board has jurisdiction over the subject matter of this case and the parties hereto.

- 2. Petitioner has applied for funding to assist in the construction of Ambar Trail, a 210-unit development located in Miami-Dade County, Florida.
- 3. Petitioner requests a waiver from the Rules, which provide, in relevant part, as follow:

Rule 67-48.0072(17)(f), F.A.C. (7/11/19)

- (17) The General Contractor must meet the following conditions:
- (f) Ensure that no construction or inspection work that is normally performed by subcontractors is performed by the General Contractor;

Rule 67-21.014(2)(r)6., F.A.C. (7/11/19)

- (r) The General Contractor must meet the following conditions:
- 6. Ensure that no construction or inspection work that is normally performed by subcontractors is performed by the General Contractor,

Rule 67-21.026(13)(e), F.A.C. (7/11/19)

- (13) The General Contractor must meet the following conditions:
- (e) Ensure that no construction or inspection work that is normally performed by subcontractors is performed by the General Contractor;
- 4. Petitioner requests a waiver of the above rules to allow Petitioner's General Contractor (GC) to perform work that is usually performed by subcontractors.

- The Board finds that granting the requested waiver will not impact other participants in funding programs administered by Florida Housing, nor will it detrimentally impact Florida Housing.
- 6. The Board also finds that Petitioner has demonstrated that the waiver is needed because of circumstances beyond its control and that it would suffer a substantial hardship if the waiver is not granted.
- 7. The Board further finds that Petitioner has also demonstrated that the purpose of the underlying statute, which is to "encourage development of low-income housing in the state," would still be achieved if the waiver is granted. Section 420.5099, Fla. Stat.

IT IS THEREFORE ORDERED that Petitioner's request for a waiver of Rules 67-21.026(13)(e), 67-21.014(2)(r)6, and 67-48.0072(17)(f), F.A.C. (7/11/2019), is hereby **GRANTED** to allow Petitioner to perform work that is usually performed by subcontractors.
