On behalf of Courtney Senior Housing Limited Partnership, the Applicant and to be ownership entity for the above referenced Development, please allow this letter to serve as the formal and written request for a substitution of the General Partner (GP) entity for Courtney Senior Housing Limited Partnership from a limited liability structure to a corporation structure.

In support of this request, please note the following:

1. The current GP entity, National Church Residences of Courtney, LLC, is a Florida non-profit limited liability company (LLC).
2. In order for The Courtney to maintain its current property tax exemption, the GP entity must be a organized as a Florida non-profit corporation and not a non-profit LLC.
3. Attached is the currently approved Principal Disclosure Form reflecting the current LLC ownership structure of National Church Residences of Courtney, LLC.
4. Attached is a new Principal Disclosure Form with the proposed corporation structure for National Church Residences of Courtney, Inc. You will note on this form that the 100% ownership by National Church Residences, currently listed as the Sole Member of the LLC will not change as a result of this substitution.
5. Please also note that we have listed the current list of Officers and Directors for Natural Church Residences since some of these have changed since the initial submission of this Form during the time the Application was submitted under RFA 2021-204.


