Also during underwriting we inserted single purpose entities (PEL Madison Oaks West LLC, NSR MOW LLC, MADPEL, LLC) in order to provide K1 to the members in Madison Oaks West Apartments, LLC. The ownership percentages are still more than 99.99 to Patrick Law. Please let me know if you need further information in order to approve this change.

We do understand that the typical process of requesting this type of change happens after the carryover but prior to the CUR. Due to the CHIRP timing and process, the carryover is now after the CUR. Seltzer is requesting that the structural change be approved by FHFC prior to the final CUR, can we please get a waiver, and have our request considered by the board at the October meeting.
