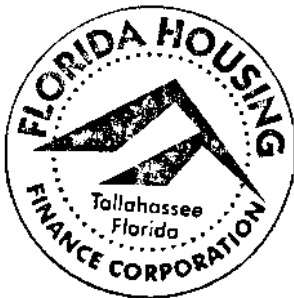
ORDER CLOSING FILE
