("Landmark"), this letter constitutes a Notice of Protest ("Notice") filed pursuant to Sections 120.569 and 120.57(3), Florida Statutes, Chapter 28-110 and Rule 67-60.009, Florida Administrative Code, and RFA 2024-202. Boulevard Gardens and Landmark protest Florida Housing Finance Corporation's ("Florida Housing") intended decision with respect to the scoring, ranking and selection of all applications submitted in response to RFA 2024-202.

This Notice is being filed within 72 hours (not including weekends) of the posting of the Preliminary Awards on Florida Housing's website on Friday, August 23, 2024, at 9:59 A.M. A copy of Florida Housing's Preliminary Awards is enclosed as part of this Notice. Boulevard Gardens and Landmark reserve the right to file a formal written protest within (10) days of the filing of this Notice in accordance with Section 120.57(3), Florida Statutes. This Notice is being filed to, among other matters, preserve Boulevard Gardens' and Landmark's ability to initiate or intervene in proceedings that may impact the scoring, ranking, and funding determinations for RFA 2024-202.
